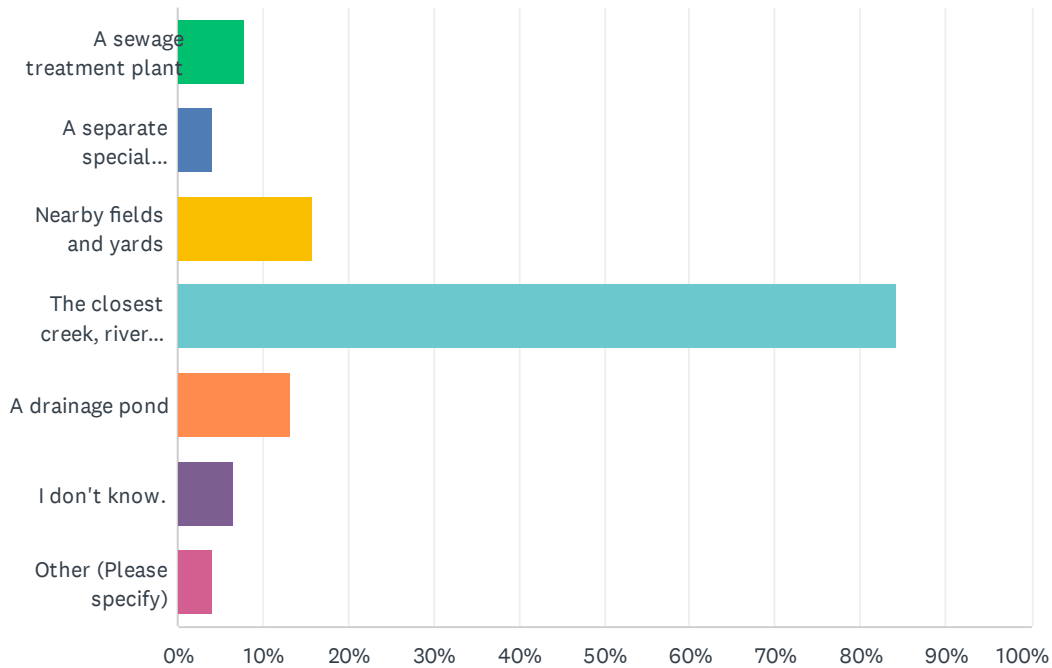

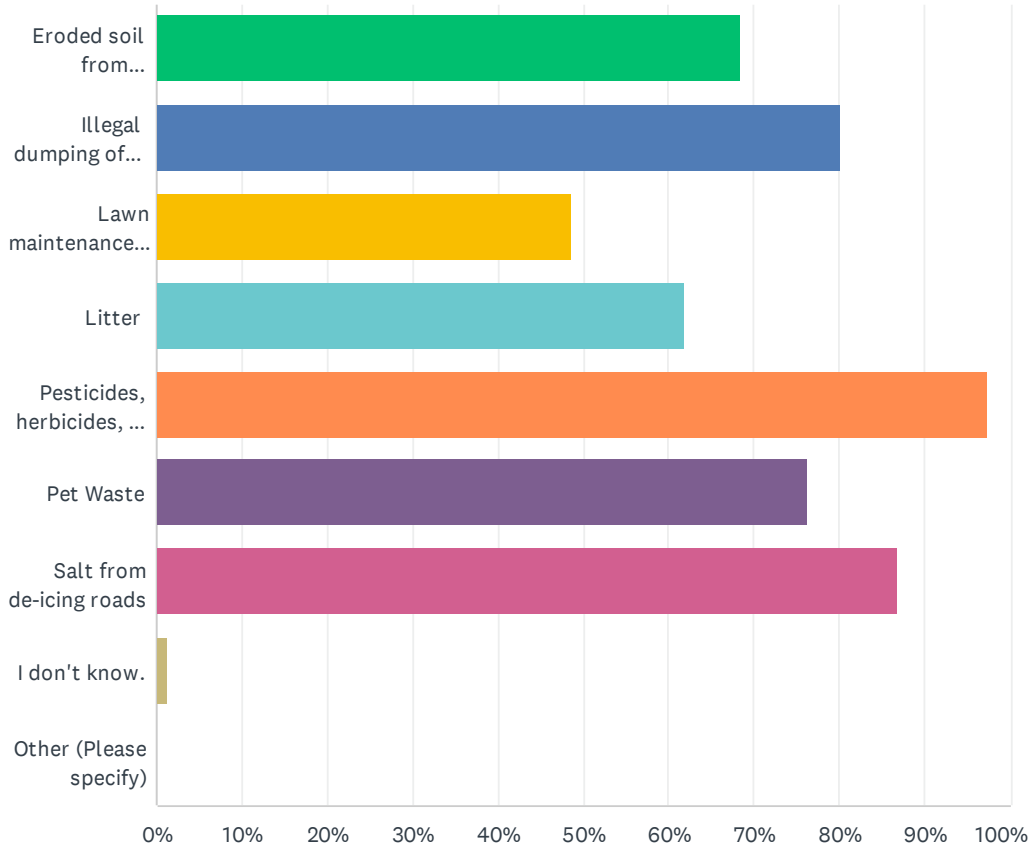

Q2 Which of the following do you think are a significant source of stormwater pollutants that may impact creek, river, or bay water quality? Check all that apply.

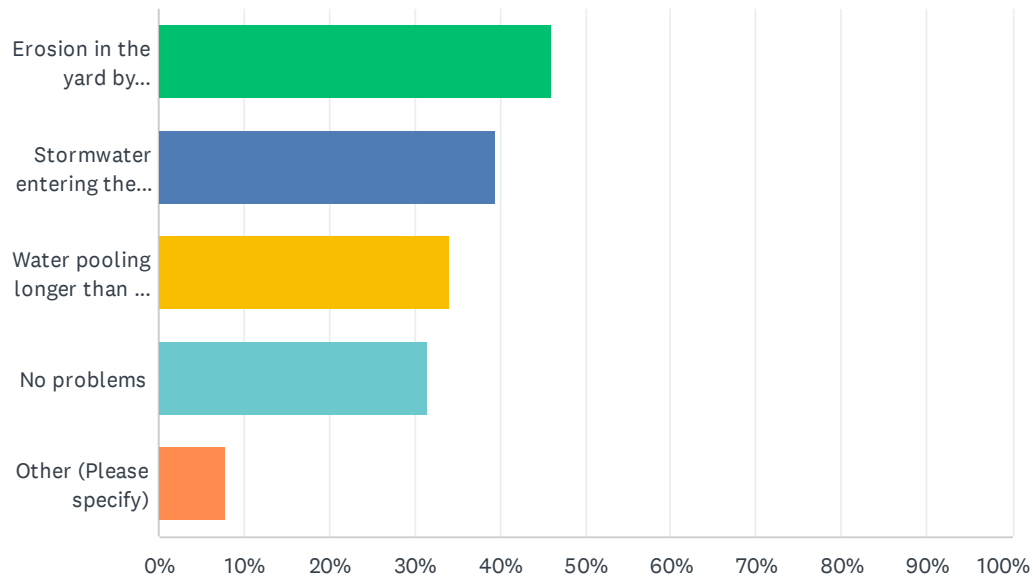

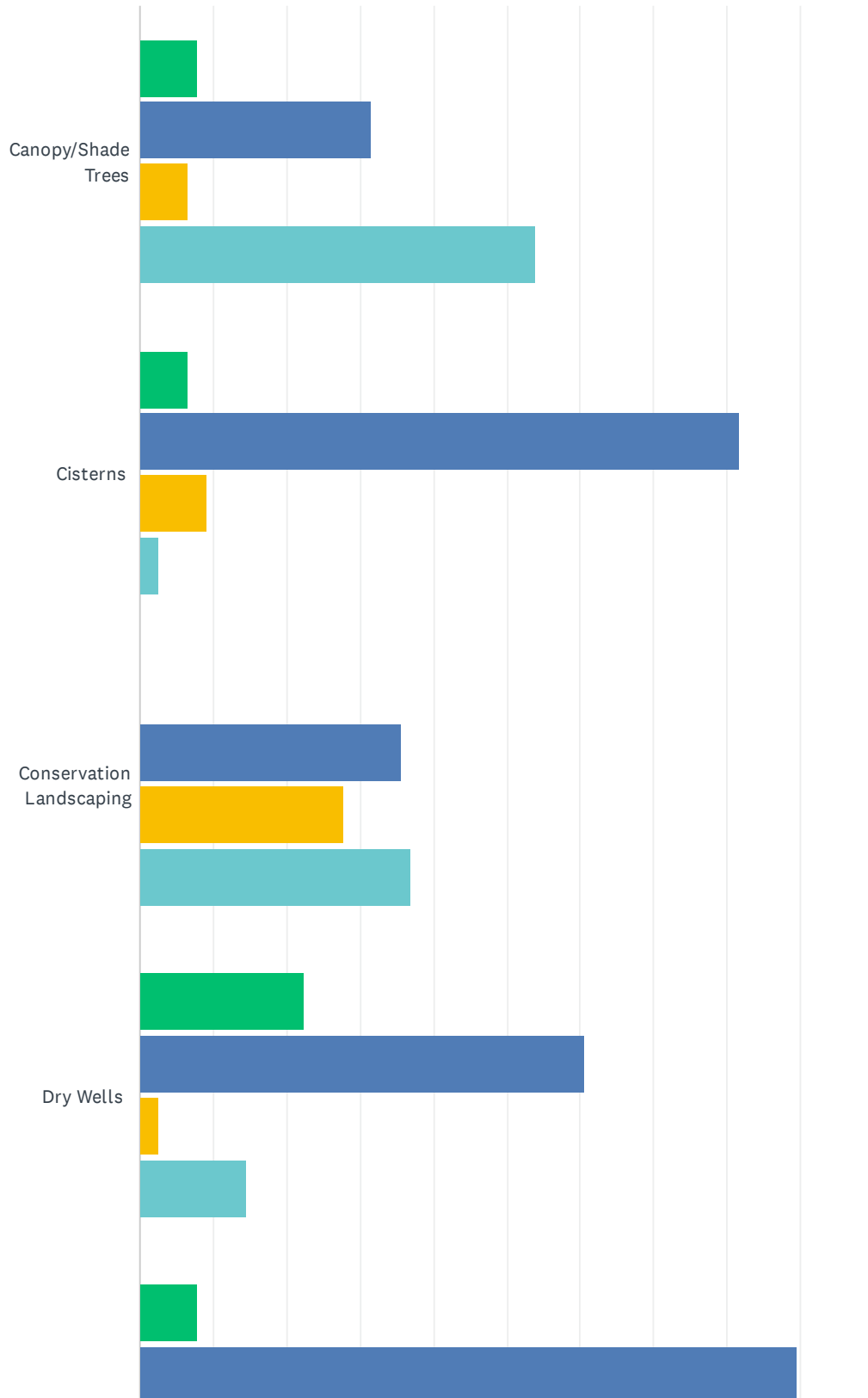

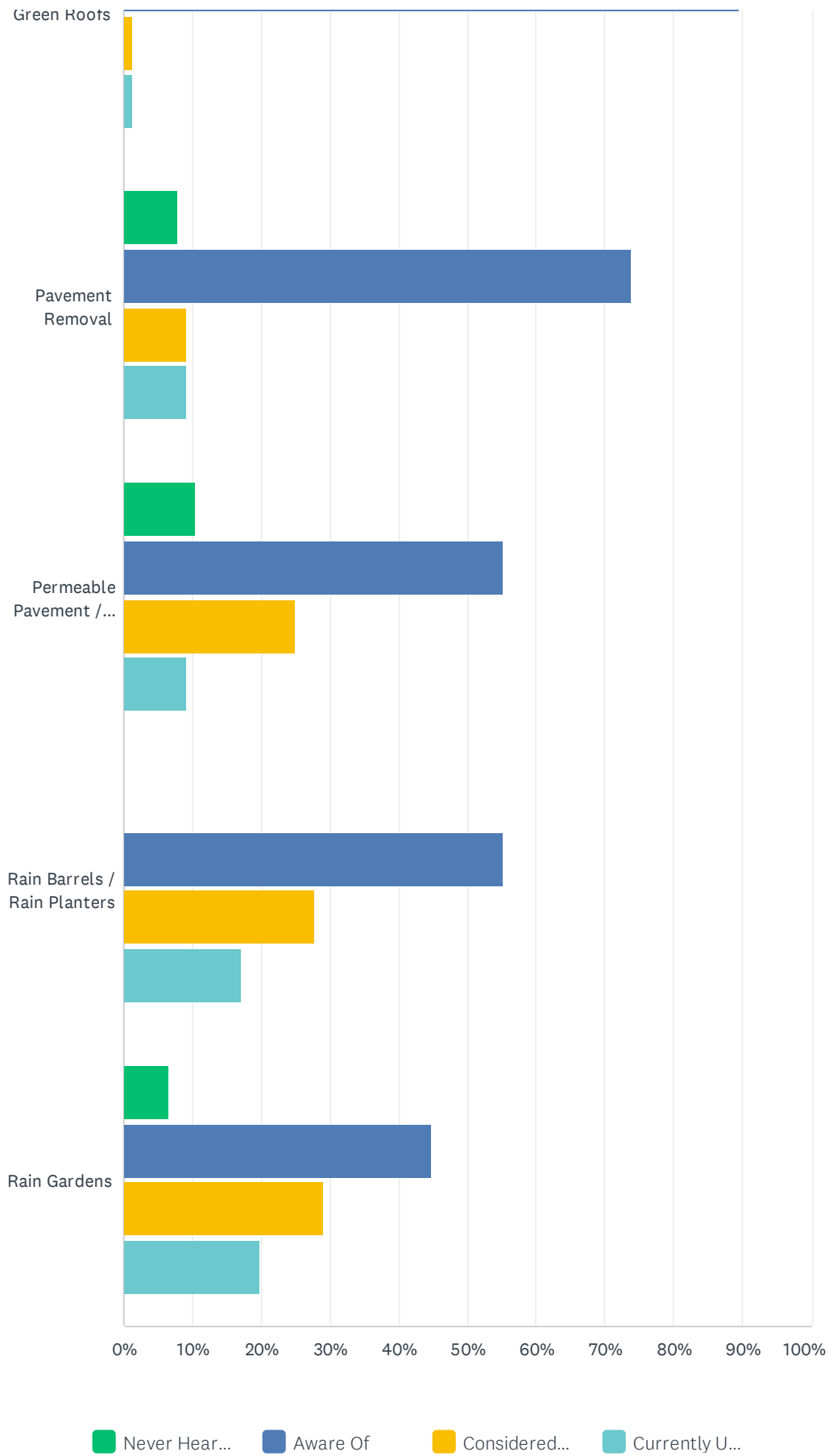

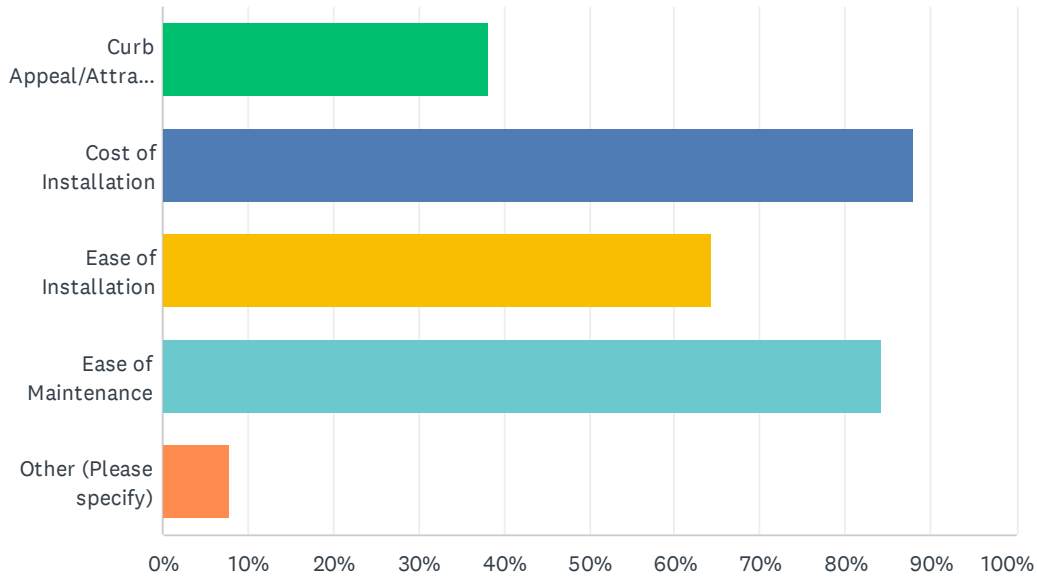

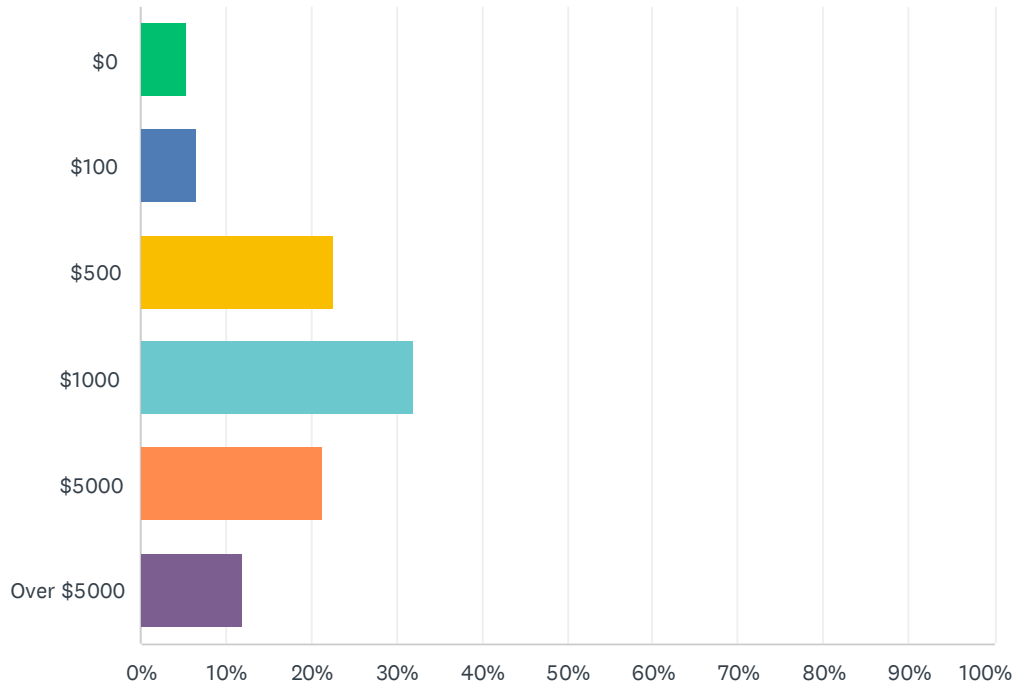

Q6 What is the most you would be willing to spend on stormwater management approaches to improve your property and the environment?

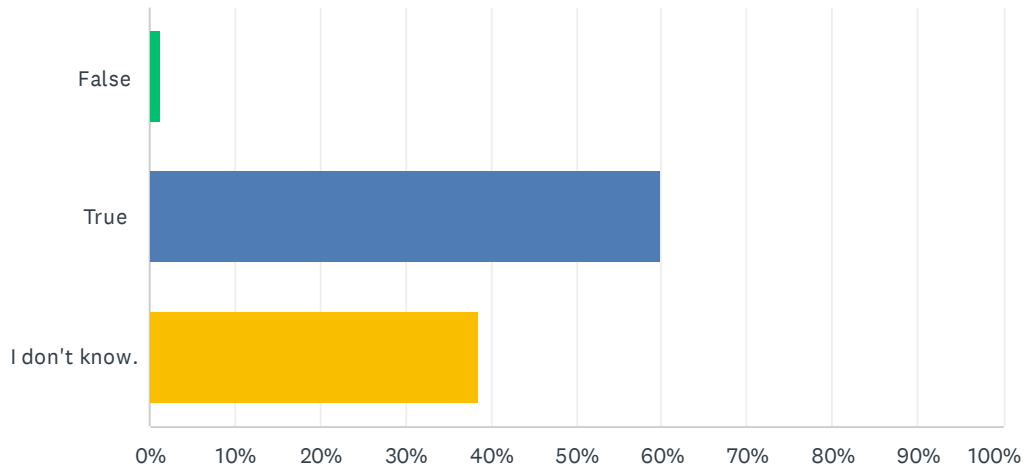

Q7 True or False: Montgomery County's Department of Environmental Protection has a rebate program to help cover the cost of installation of a stormwater management approach.

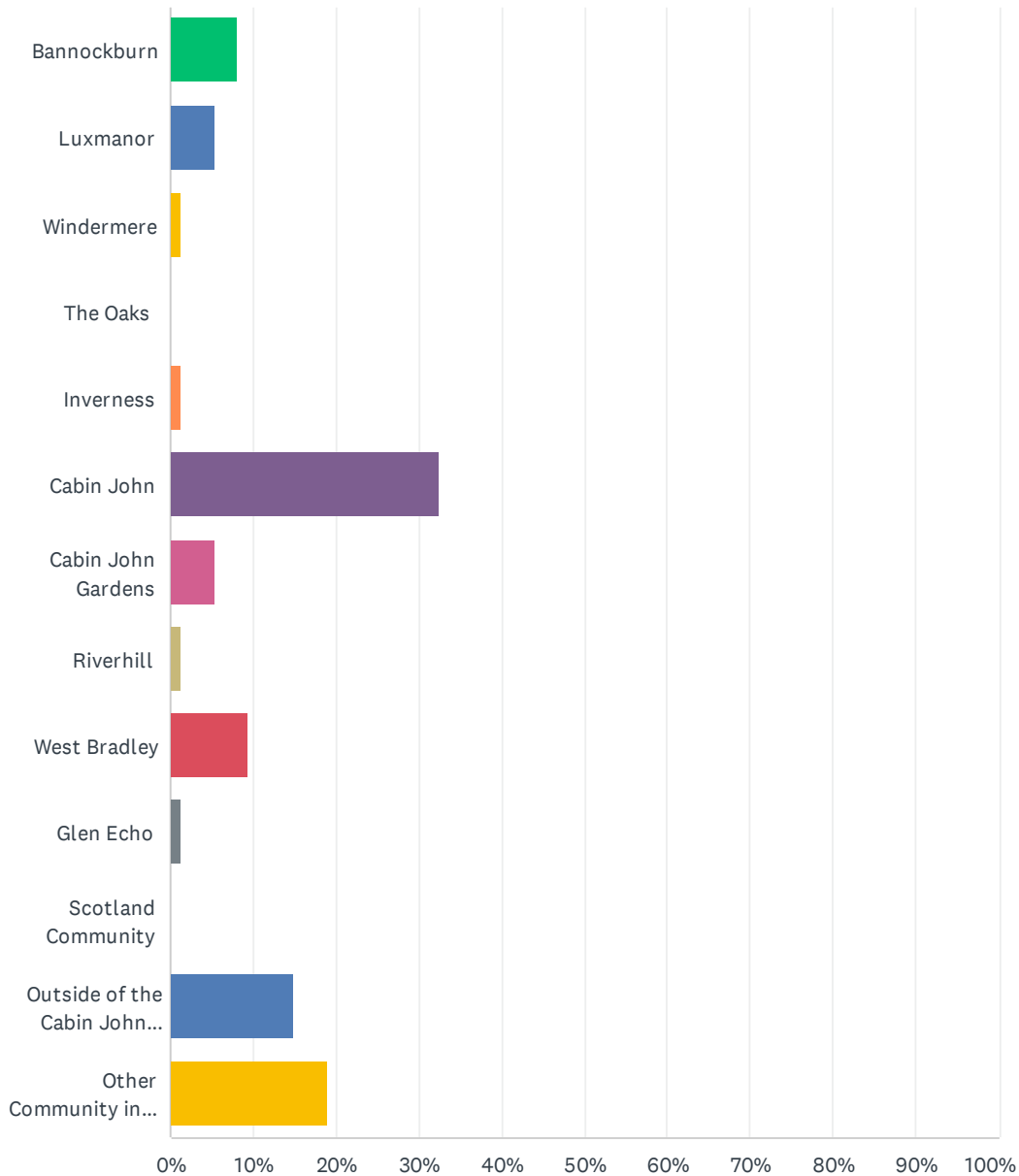

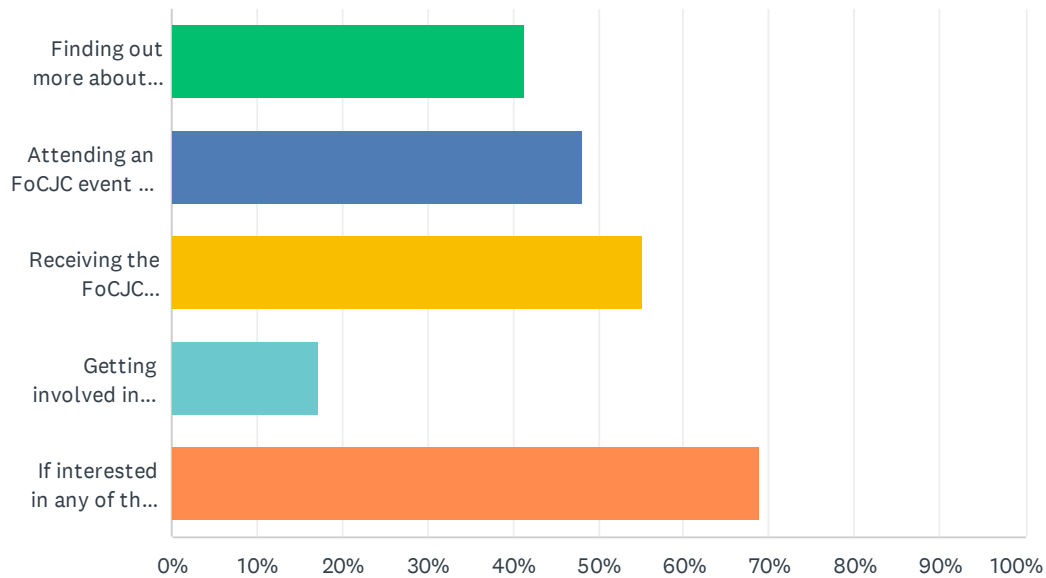
